LETTER FROM THE PRESIDENT

Dear Friends,

Thank you for your continued dedication to The Cam Neely Foundation for Cancer Care and its mission. With your help, we accomplished a great deal in 2006 — in particular, meeting nearly half of our \$5 million fundraising goal to establish The Michael Neely Center for Brain Tumor Care and Research.

Losing our parents to cancer propelled my siblings and me to create The Cam Neely Foundation. Their memory sustains our mission to provide comfort, support and hope to other cancer patients and their families. Our mission inspired plans to create The Michael Neely Center for Brain Tumor Care and Research — our fifth project at Tufts-New England Medical Center. The Center will be named in memory of my father who lost his battle to a brain tumor. The project means so much to the Foundation — and especially my brother, sisters and me. It is the first Foundation endeavor that directly affects a type of cancer that affected our family personally.

Already, funds are being put to great use. We completely renovated the Department of Neurosurgery's physician office suites and patient waiting area at Tufts-New England Medical Center, tripled the number of clinical exam rooms from two to six and purchased several pieces state-of-the-art diagnostic and neurosurgical equipment. These changes have made an immediate impact not only to cancer patients and their families, but to hospital staff alike.

We look forward to an exciting and rewarding year ahead. Thank you for all that you have done — and all that you continue to do — to support our great foundation.

The Neely House and The Neely Cancer Fund: *Working Together To Provide Comfort, Support and Hope to Cancer Patients and Their Families*

In 2002, Laura Ullman learned she had a malignant brain tumor. A healthy, vibrant wife and mother of two boys, Nate, now 12, and Noah, now 11, Laura was unfettered in her fight. Together with her husband, Joe, a radiologist practicing in Maine, Laura combed local hospitals for treatments and protocols. Later that year, Laura underwent surgery at a small hospital in Maine. Astounding results left Laura in great spirits. The Ullman family traveled to Ireland to celebrate her recovery. “She was drinking beer and climbing rocks,” said Joe of his wife’s morale.

Nineteen months later, another surgery followed, along with radiation therapy, chemotherapy protocol and a series of other treatments. The treatment was again received well, prompting another family vacation, this time to Napa Valley, California.

Then a tumor invaded the opposite side of Laura’s brain in November 2005, worsening her speech and diminishing her vision. When an experimental protocol failed, doctors advised the Ullmans to head to a bigger hospital for more aggressive treatment. Julian Wu, MD, FACS, Chief, Division of Neuro-Oncology at Tufts-New England Medical Center, was among the local hospital’s recommendations.

Consequences of a third surgery would be severe, risking speech and potentially leaving Laura in a vegetative state. There were other issues at stake too.

“A hospital can be such a terrible experience. The Neely House was such an important place,” said Joe.

“We struggled with the decision to take Laura out of a comfortable environment and transfer her to a big city medical center,” said Joe. Impressed by Dr. Wu’s demeanor and patience, the Ullmans left the comforts of Maine for Boston. Using the new state-of-the-art frameless stereotactic navigation system purchased by The Neely Foundation, the outcome of Laura’s surgery was terrific – even resulting in slight improvements in her impaired speech, memory, and sight.

“We felt like we dodged a bullet,” Joe said of his wife’s enhanced state.

While Laura was admitted to Tufts-New England Medical Center, Joe and his sister-in-law, Kathy, stayed at The Neely House at Tufts-NEMC.

“A hospital can be such a terrible experience. The House was such an important place,” said Joe. “Patricia was always there,” he said of House Manager Patricia Rowe. “She was as part of the team as doctors and nurses. Nothing went undone.”

Laura, Joe and Kathy stayed in Boston through Laura’s post-operative hospital course. Two months after surgery, a follow-up MRI showed Laura’s tumor had come back aggressively. Laura lost her battle on October 5.

“We wouldn’t have done anything differently,” said Joe of his wife’s treatment options. “Dr. Wu faced a challenging situation and did what was asked of him.”

“The nurses at Tufts-NEMC were unbelievable. It didn’t matter what time it was or how busy they were. They were caring, responsive and professional — giving us personal treatment rarely found at a big hospital.”

“There isn’t much of an upbeat side to a brain tumor in a 47-year-old mother of two, but The Neely House and the team of physicians certainly made a huge difference. It’s nice to be able to say come check out Tufts-New England Medical Center and The Neely House because they’re doing it right.”

Laura was 47 years old.



Teeing Off Against Cancer

On Wednesday, October 4, more than sixty golfers took part in the first annual Good Guy Invitational at Boston Golf Club in Hingham, MA. The day-long golf tourney was produced and planned by Golf Fights Cancer (GFC), a charity dedicated to raising funds for cancer-related charities and research organizations.

With the goal of fighting cancer and making financial contributions that can make immediate, tangible differences, GFC selected The Cam Neely Foundation for Cancer Care as the recipients of its next donation.

“I have long admired the great work of Scott, Cam and all the people at The Neely Foundation” said Brian Oates, co-founder of Golf Fights Cancer. “We are thrilled to support the Foundation and are proud to make a contribution of \$100,000 from the first Good Guy Invitational.”

Golf Fights Cancer’s donation will be earmarked toward the purchase of a new Leica Microscope and Digital Recording System for the Neurosurgery Department at Tufts-New England Medical Center. Installed in the operating room and utilizing a digital video recording system, this equipment provides surgeons with immediate and vital information on brain tumor specimens during surgery.
